iii. Payments shall be made as follows:


#	Stages of Payment	Delivery wise payments percentage (including taxes)
1	On submission of raw data in electronic format along with canvassed filled in interviewed schedules- 1 <sup>st</sup> instalment	10 per cent of contract value including taxes.
2	On submission of final data, tables and acceptance of the same by DES- 2 <sup>nd</sup> instalment	20 per cent of contract value including taxes.
3	On submission of draft evaluation report covering detailed analysis, findings and recommendations - 3 <sup>rd</sup> instalment	20 per cent of contract value including taxes.
4	On acceptance of final report by the committee constituted – Last instalment	50 per cent of contract value including taxes.

- iv. Period of the study: - Evaluation study to be completed within 120 days. The delay beyond 120 days shall attract penalty and same shall be imposed as per the penalty clause mentioned in the tender document.
